FELIS BRITANNICA PEDIGREE REGISTRATION FORM GUIDANCE NOTES

1 Registering Club

You must belong to one of the Felis Britannica member clubs in order to use Felis Britannica's registration services and through which to process your registrations – all registration applications must be sent to that club. Enter the membership number you hold with the club to process your registrations.

2 Cattery Name

The cattery name used must be that of the owner of the dam at the time of mating. The cattery name can **ONLY** be used for litters conceived after the cattery name has been granted. If you do not have a FIFe registered cattery name, a Felis Britannica admin prefix will be used, for a maximum of 2 litters. A jointly owned cattery name may only be used when the dam is also jointly owned.

3 Mating Certificate

A mating certificate signed by the stud owner(s) is required for all registrations where the owner of the dam does not also own the stud, or where the stud is not registered with Felis Britannica.

4 Certificate of Entirety

A Certificate of Entirety is required for all un-neutered males over 10 months of age before their offspring can be registered.

A Certificate of Entirety must always be sent with a litter registration if the sire is not registered with Felis Britannica.

5 Certificate of Hearing

A Certificate of Hearing is required for all solid white cats and kittens before they can be shown or their offspring registered.

6 Certified Pedigree

An original minimum 3 generation pedigree is required when importing a cat or kitten from any other registry into Felis Britannica. If a 3-generation pedigree is supplied, and the 4th generation information is not already available the imported cat will be registered on the RIEX register.

An original certified pedigree for the sire must always be sent with a litter registration if the sire is not registered with Felis Britannica.

A pedigree emailed from GCCF is acceptable in its original form.

7 Import and Export

If you are importing a cat into Felis Britannica from any other registry you must provide proof of ownership.

8 Microchip Numbers

All Felis Britannica breeding cats must be micro-chipped.

Where a microchip number is to be registered on the FB data base, an official document showing the name of cat & the microchip number must be provided. (i.e. original chip cert, CoE for males, Pets Passport, vaccination certificate), for imports the number may already be included on the pedigree.

9 Litter Registration Fees

The fee of either £7.50 or £10.00 (depending on whether one or both parents are Felis Britannica registered) is a charge for a whole litter.

The breeder **must** also select either a 4 or 5 generation pedigree for each kitten in the litter and pay the appropriate fee.

Effective from 1st January 2014, all litters must be fully registered, declarations are no longer allowed.

Effective from 1st June 2017, all imports from other FIFe registries will be issued with a 4 generation pedigree.

10 Breeder

The breeder is the owner of the dam at the time of mating.

11 Name of Cat or Kitten

The name of the cat or kitten, including the cattery name (prefix or suffix) must not exceed 35 characters including spaces.

12 Breed, Colour and Pattern

This must be described for every kitten in a litter and must match the EMS code. For cats being imported from another registry, these are the details as given on the original registration.

The code for eye colour must be used if the cat is white, and for cats with 01,02 amounts of white.

The code for eye colour must be used for EXO/PER and BLH/BSH if the cat is silver tabby and its variety is not limited to one eye colour.

BML, EMS code is only to be used for an agouti silver or golden short haired shaded or tipped cat. Any Asian, in all varieties will be EMS coded ASH-non or ALH-non depending on whether the Asian is short or long haired.

13 Endorsed

Tick this box if you do not wish the kitten to be used for breeding. A kitten with an endorsed parent or parents is not eligible for registration. Endorsements may only be lifted by the breeder.

14 Genetic Tests

Genetic tests are required for certain breeds, please check the FIFe rules and ensure that the required tests have been carried out, and the results registered with FB.

Currently tests are required for PER/EXO (FB Rule) ,BUR ,KOR and NFO.
